CARRY-ON BAGGAGE

With limited cabin stowage space available, the following limitations apply:

Economy Class passengers are allowed one piece of carry-on baggage.

First and Business Class passengers are allowed two pieces.

This regulation applies irrespective of any other frequent flyer membership benefits.

In exceptional cases, we will ask our guests to check in their carry-on baggage, mainly on flights operated by a regional aircraft (e.g. Avro RJ 85/100).

HANDGEPÄCK

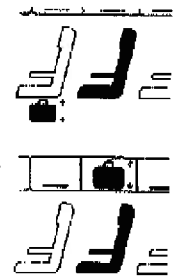
BAGAGES A MAIN
