I am writing on behalf of a constituent in my district, Mr. George Petroutsas. He has contacted my office seeking assistance regarding his child, Andoni Petroutsas, who remains in Greece with Mr. Petroutsas' ex-wife, Despina Avesta Petroutsas, against his wishes.

According to Mr. Petroutsas, he has won a Hague case stating Andoni's habitual home is the United States. Ms. Despina Petroutsas was ordered to return to the United States with Andoni on June 19, 2010 and return him to the custody of his father. Unfortunately Despina never returned with Mr. Petroutsas' son. I have attached a copy of the court order for your records.

Mr. Petroutsas is requesting your assistance in the safe return of his son to the United States. He would like to be assured that the US and Greece is doing everything in their power to support the Hague Treaty. He would appreciate any assistance in the return of Andoni, his son, to his habitual country, the United States.
